4 First aid measures

- **After inhalation:** Supply fresh air; consult doctor in case of complaints.

Rinse opened eye for several minutes under running water. Then consult a doctor.

Do not induce vomiting; call for medical help immediately.
- **Information for doctor:**
High pressure injection injuries through the skin require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be

necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.

- **Material of gloves**
